TSCA (Toxic Substances Control Act)

Dear Madams and Sirs,

Thank you for your inquiry regarding the Toxic Substance Control Act (TSCA).

The U.S. Environmental Protection Agency (EPA) has adopted TSCA Section 6(h), which addresses five persistent, bioaccumulative, and toxic (PBT) substances, effective March 8, 2021. The regulation does not allow the use of the 5 substances listed below.

- PIP (3:1) – Phenol, Isopropylated Phosphate (3:1) (CAS-Nr.: 68937-41-7)
- DecaBDE – Decabromodiphenyl ether (CAS-Nr.: 1163-19-5)
- TTBP – 2,4,6-Tris (tert-butyl)phenol (CAS-Nr.: 732-26-3)
- HCBd – Hexachlorobutadiene (CAS-Nr.: 87-68-3)
- PCTP – Pentachlorothiophenol (CAS-Nr.: 133-49-3)
